CEO Member Report



Core Review

One of new initiatives that may impact the continuing care sector is the BC government's Core Review. Minister Bill Bennett is responsible to undertaking the review which will begin in earnest this fall.

Bennett has been asked by Premier Christy Clark to draft the terms of reference which will be approved by Cabinet later this year. Once those are complete, the work of consulting with industry will begin.

Here is an excerpt from Province newspaper columnist Michael Smyth whereby he speculates on what might be about to transpire:

"Bennett is not a guy who's ever been afraid to challenge the powers that be, creating some apprehension about just what he has in mind.

After all, the last time the government went through this exercise was 2001, when then-premier Gordon Campbell's core review led to the infamous "Black Thursday" budget cuts and public-sector layoffs.

Bennett (no relation to the former premier of the same name) was a Liberal backbencher at the time.

"We were ruthless," he said. "Campbell came in and said, 'Cut 25 per cent out of every ministry except health and education.' I think we were even mean at times."

He says Core Review 2.0 will be different. Vulnerable people who rely on government services — he mentioned seniors, disabled people and single mothers — should not worry about major program cuts, he said.

"My purpose is not to go in with a big axe and start chopping," Bennett said.

But this is the same government that just brought in a \$25-a-month wheelchair "maintenance fee" in provincial nursing homes. And Bennett said his core review — which will take over a year to complete — could still result in unpopular decisions.

"You can't make an omelette without breaking a few eggs," he said.

Will the review result in downsizing of the government workforce?

"We already have the leanest public service in Canada and we're

in a hiring freeze now," he said. "That doesn't mean there won't be anybody laid off. There may be some reductions, but I'm convinced it won't be sweeping."

The Minister has taken the first step of requesting the private and non-profit sector to help identify areas of waste, duplication and inefficiency. He stated in a June 26th interview with the CBC's Rick Cluff:

"...I want to make use of anyone in the public, anyone in the private sector, businesses, non-profits, anyone who has an interest in helping us and identifying things that we're doing that don't look to be effective or efficient. I want, you know, people outside Victoria to be involved in this process so I think that's important."

What follows is a complete transcript of that CBC interview.

Rick Cluff: MLAs get back to work at the BC Legislature today. The summer session begins with a focus on how to keep the government's purse strings tight, as the Liberals aim to deliver a balanced budget. Bill Bennett is the Minister Responsible for the Core Review, he's also the MLA for Kootenay-East. Minister, good morning.

Bill Bennett: Good morning, Rick.

Rick Cluff: You are the Minister of Belt-tightening, correct?

Bill Bennett: [laughter] Well, I am one of the Ministers of Belt-tightening. The Finance Minister would probably take issue that I'm the Minister of Belt-tightening because he has a big role in this as well.

Rick Cluff: Minister, the last time that we had a core review in BC was back in 2001 under the Gordon Campbell government. It led to massive budget cuts, and public sector layoffs. Now, should we expect more of the same this time around?

Bill Bennett: No, I don't think that people should expect certainly not massive layoffs. We have the leanest public service in the country now in British Columbia. People in the public service in my experience do a very good job and they work hard, so we're not expecting to find, you know, hundreds and hundreds of jobs that are unnecessary. The focus here, Rick, is taxpayer focused. I'm going to be approaching this job in this way: I'm going to be saying to myself, and I'm going to be asking the other Ministers and MLAs on this Core Review Committee, to consider that the money we have in government to spend is not government's money — certainly not our money. It's tax money people send us, and I want them to think about, you know, the single mom, you know maybe earning \$35, \$40 thousand dollars a year who sends the government a few thousand dollars each year in tax money. She works really, really hard for that money. She could use that money. But she sends it to

the government because she has to and she wants to contribute. We want to make sure that every single dollar that's being spent by a ministry or crown corporation is treated respectfully considering its source.

Rick Cluff: An honourable cause, but very difficult to do. The last core review took place over a three year period. How long do you expect this one to last, since your government wanted to balance the budget by this time next year?

Bill Bennett: Well, my mandate is very clear. Premier Clark gave each Minister a letter and spelled out very specifically what our duties are. And my duty with respect to the Core Review is to be done by December of 2014. My first important date I guess is late August when I'm supposed to have and will have a complete terms of reference done, take it to Cabinet, Cabinet will have a discussion. They'll either approve it or modify it, and that's when we're actually going to get to work and start finding ways that government can do things more efficiently.

Rick Cluff: Minister, back in February, your Cabinet colleague Mike De Jong the Finance Minister, said the province was dealing with a 1.2 billion dollar deficit. At the same time though, he projects a surplus of about 197 – 200 million dollars by 2013, 14. How do you bridge that gap?

Bill Bennett: With great difficultly, Rick. It's a big challenge and I know going into the election, the opposition and members of the public were very skeptical. I think they were skeptical not only about our capacity or ability to do this, but about our sincerity. And I can tell you our sincerity is absolute. We intend to do this. One example of how we're going to do this is the Health Minister has been given marching orders to restrain the growth of health spending to a level less than at any time in our government's history. So, within the last 12 years. We've seen health spending in BC go up, certainly less than other provinces but still 6, 6 and a half, 7 years some years. We just, you know the people in the province can't afford that expansion of cost so the Health Minister is going to have to keep his costs down around 2 and half percent a year. That will help. I will probably, we'll find out, but I'll probably be charged in my Core Review process with meeting a financial target. So I'll be responsible for finding some specific savings. Other Ministers are going to be charged with finding some specific savings. We're absolutely determined to do this because we think it's important.

Rick Cluff: But Minister, let's look at one specific. You brought up health care. It's all well and good to say we want to cut the costs of health care, but nonetheless, the population of British Columbia is aging and the strain on the health care system is increasing, so how do you balance those two?

Bill Bennett: Well, it's important that we use the right language

when we talk about health care. I didn't say that we're going to cut the costs of health. I said we're going to restrain the growth in health care spending, so health care spending will continue to go up as it always has, ever since the baby boomers like myself came along, and it'll continue to increase. The challenge is just making sure it doesn't increase beyond the public's capacity to pay for it. And you know, we should be proud here frankly in British Columbia that we have some of the very best outcomes in health, but yet we're spending less per capita than many provinces. So we're doing something right and we need to build upon the successes that we've discovered over the past 12 years.

Rick Cluff: Minister, what areas specifically will you target?

Bill Bennett: We're going to look at everything, Rick. We're going to look at absolutely everything in government. We'll have an eye certainly for waste. We'll find some of that. There's always some of that in government. There's always some of that in crown corporations. We're also going to look for redundancies and duplication. We're going to look for situations where perhaps the public taxpayer is paying for something that could be more effectively delivered by the private sector. We did that in our first core review, we'll do that again. Everything is on the table. Nothing is sacred. We're going to have to look at absolutely everything that government does if we're going to accomplish what we aim to accomplish.

Rick Cluff: It's interesting the difference between the core review 2001 and this one is the last one, the 2001, followed an NDP government. How difficult is it going to be for the BC Liberals to look at what they have done themselves over the last decade to make a more lean running government?

Bill Bennett: Well, you're right to focus on that, Rick. I mean, there's two things there. One is that we're looking at what we have done and what we are doing, so there is a potential for an internal bias and in that regard I want to make use of anyone in the public, anyone in the private sector, businesses, non-profits, anyone who has an interest in helping us and identifying things that we're doing that don't look to be effective or efficient. I want, you know, people outside Victoria to be involved in this process so I think that's important. I do think that the other thing is that in 2001 we were elected after 10 years of NDP government and free enterprise voters certainly expected us to come in and shrink the size of government, and there was a belief at the time and I certainly shared that belief that there was a lot of waste and it turned out that there was. We're not anticipating a lot of low hanging fruit so to speak. We're anticipating that have to work pretty hard to find the savings that we need to find.

Rick Cluff: Minister, thanks for your time this morning. And we'll chat again.

Bill Bennett: Okay, Rick. Thanks.

Safecare BC Update

Over the last year, the Association has been consulting with the continuing care sector in preparation for the establishment of a new safety association (SafeCare BC). An application was made in 2012 and it was anticipated a decision would be made by last Spring regarding whether it would be approved.

In late June the BCCPA was advised by WorkSafeBC that our application would not be reviewed by their Senior Executive Team until at least this Fall.As a consequence, a <u>letter was sent</u> to Vice-President lan Munroe expressing our deepest concerns regarding ongoing administrative delays.

The BCCPA has subsequently spoken with WorkSafeBC and agreed to participate in one final consultation session to be held on August 19th at 11 am. During this session WorkSafeBC will consult with the sector regarding any possible rate adjustments being proposed for 2014 as well as provide an update on next steps for the SafeCare BC application.

Once this final consultation is held, we remain hopeful we will receive rapid approval to move forward with the establishment of SafeCare BC.

As has been clearly demonstrated in Alberta, the creation of their safety association has had a very significant impact on helping to lower Worker's Compensation premiums for the continuing care sector.

BCCPA Hosts Roundtable With Non-member Non-profits

On June 21st a special roundtable was held with a number of non-member non-profit service providers. The session was generated through several inquiries about how the BCCPA could further expand its membership base into the non-profit sector. Approximately 35% of our current membership base are deemed non-profit.

A number of great ideas were generated and the two-hour session proved to be very productive. One of the main topics discussed was how the Association could become more inclusive of smaller non-profit service providers.

One issue raised was the misconception that the BCCPA is still working under the same model as the former "BC PriCare" – and thus only serves for-profit providers.



BCCPA Expands Reach With Stakeholders



Earlier this year the **CD Howe Institute** invited the BCCPA to sit on its <u>Health Policy Council</u>. In May I attended my first meeting in Toronto with key academics, business and thought-leaders from across Canada.

The C.D. Howe Institute's Healthcare Policy Initiative is a four-year program

to produce research, analysis and events to raise the level of debate around Canadian healthcare and to help motivate policy improvements. The program will address critical issues such as: international lessons on financing and incentives; defining the services provided under public plans; incentives and funding arrangements for hospitals and healthcare providers; federal and provincial policy on pharmaceuticals; options for primary-care reform; access and quality of care. As with all the Institute's work, the program aims to provide research that is rigorous, evidence-based, and peer-reviewed, recommendations that are relevant, constructive, and timely, and communications that are clear, authoritative and practical.

In July, we also learned that **Heather Campbell**, Director of Policy and Research, has been accepted to sit on the executive for the **Canadian Bar Association's** (BC Branch) Elder Law Section. The executive addresses legal issues of seniors such as medical and housing matters, elder abuse, mental capacity and consent, and guardianship.

BC Care Aide Registry

The BCCPA met with Bruce Bell from the BC Care Aide Registry in late June. We discussed some of the ongoing challenges facing the Registry as it follows up from the recently released Murtagh Report.

The Association remains actively engaged in wanting to reform the Registry to ensure it is working for those in care – as well as individuals working within the sector. To that end, we will continue to convey our member's concerns regarding some of the key issues we identified <u>earlier in correspondence</u> sent to the Registry.

We are also sitting on the Registry's Health Care Assistant (HCA) Education Standards Advisory Committee, where we are representing our members' interests regarding the implementation of the new HCA program recognition process.

View From Victoria



The BC Legislature is now back in session effective June 27th. Minister of Finance Michael de Jong has re-introduced Budget 2013 for debate. The session is anticipated to last about six weeks with the sole focus being the passing of the budget bill.

The Hon. Terry

Lake has taken over from **Margaret MacDiarmid** as the new health minister. He is also responsible for the seniors' portfolio. MLA **Linda Larson** will be working with Lake as the new Parliamentary Secretary responsible for seniors.

The BC Liberal government has also re-constituted the Standing Committee on Health. According to a tweet sent out by Vancouver Sun political columnist, it will "further study the impact of an aging population on the sustainability of the system." We will keep you posted as there are new developments.

What follows is a brief analysis provided to the BC Care Providers by Fleishman-Hillard regarding the Victoria scene:

"Minister of Finance Hon. Mike de Jong introduced a Budget with updated fiscal numbers. The previous budget announced in February had not been passed before the legislature was dissolved for the 2013 provincial election.

The Budget released today was similar to the Budget tabled in February, however, reflects some moderate changes in economic and revenue forecasts. The Economic Forecast Council has revised its projection for provincial real GDP grown in 2013 to 1.6 per cent, down from 2.1 per cent in January.

Further fuelling the lower economic projection are decreases in retails sales, job growth and housing starts. The employment growth rate was predicted to be 1.1 per cent and is now at 0.7 per cent. This equates to a difference of 9,000 fewer jobs than the previous forecast. Retail sales growth was predicted to be 3.5 per cent, but is now at 1.8 per cent. Further, housing starts were predicted to be 24,679, but are now at 23,800. A small increase was forecasted in resource revenues, with the government signallying an increase in the price of natural gas.

In order to maintain a balanced Budget, the government will continue its expenditure management controls: an additional \$130 million in cuts to provincial spending over the next three years are being instituted; and, a core review of all government spending is targeting an additional \$50 million in spending reductions and efficiencies. The Budget, however, does maintain new investments in early childhood development and registered education savings plans (RESPs) for children born after 2007.

Policy on Chargeable Extras

As many of our members are aware, there has been a significant amount of media attention paid to the issue of the Health Authorities charging residents a rental feel for wheelchairs. The BCCPA did conduct an interview on the **Bill Good Show** on CKNW radio regarding this issue. You can click here to listen.

We have been advised the Health Authorities are currently reviewing their policies to ensure that "clients moving into publicly subsidized residential care, regardless of whether HA owned and operated, will receive consistency in what is included in their client rate, and what is a chargeable extra, including what they are personally responsible for."

The Association will be consulted as part of this policy review in order to ensure the views of our members are taken into account. We have been advised that the work from this policy review will be incorporated into the standardized contract template work, which is being undertaken in response to Consumer Protection BC's determination that the Business Practices and Consumer Protection Act applies to all service providers of community care facilities and assisted living residences. Specifically, Consumer Protection BC has determined that contracts of this nature are "future performance contracts" and therefore, must include the legislated list of required information, such as an itemized purchase price for the goods and services that will be supplied under the contract.

Policy and Research Scan



National

Elections Canada is seeking input on issues **electors in long term care** may encounter when registering and voting at the polls. Feedback

British Columbia

The BC Patient Safety & Quality Council has launched its new initiative that aims to reduce the use of anti-psychotic medications in residential care. The goal of CLeAR – a **Call for Less Antipsychotics in Residential Care** – is to reduce anti-psychotic drug use by 50% across BC by December 31, 2014. The **Provincial Violence Prevention Curriculum** is now available on the HEABC <u>website</u>. Created by the Provincial Violence Prevention Steering Committee, the curriculum was developed to fill a need for effective, recommended and provincially-recognized violence prevention training for all BC health care workers across a range of care settings. The curriculum, which includes eight e-learning modules, provides employees with education and tools to prevent, defuse and/or deal with potentially violent situations to reduce the risk of injury and also to ensure that employees feel safe in their workplaces.

In June 2013, **BC's Information and Privacy Commissioner** released her <u>investigation report</u> that examined three breaches of personal health data. Ministry of Health employees were able to download large amounts of personal health data onto **unencrypted flash drives** and share it with unauthorized persons, undetected. The report recommends that employees should not use portable storage devices, such as laptops, flash drives and CD-ROMS, except as a last resort, and even then, such devices should be encrypted. The report notes, however, that encryption is not the complete solution. "Public bodies and private sector organizations need to explore alternative secure methods of remote access to personally identifiable information, and resort only to encrypted portable devices when all other, more secure, options are not available."

On June 18, 2013, **BC Ombudsperson Kim Carter** released her 2012/13 annual report, which includes updates on actions by government regarding the 176 recommendations made

in her systemic report on seniors care: The Best of Care, Getting it Right for Seniors in British Columbia. The report also provides updates on the investigation into VIHA's process for closing Cowichan Lodge, a seniors' residential care home in Duncan, and the process for appointing the Public Guardian and Trustee to manage the financial affairs of incapable adults, who in some cases may be a long term care resident. Alberta

Starting January 2014, Alberta occupational health and safety officers will be allowed to issue **tickets for violations**. Tickets can be handed on-the-spot to workers and employers, with fines up to \$500. The draft <u>list of ticketable offences</u> is very specific; however, very few pertain directly to the continuing care sector (Alberta Continuing Care Association, June 2013).

Alberta Health Services <u>reversed its decision</u> to cancel **home care contracts** with three providers, and it also withdrew its **I 00 km first available bed policy**.

Ontario

Ontario is increasing the number of LTC inspectors to perform **unannounced comprehensive** Resident Quality Inspections. The inspections are conducted by a team of inspectors over a number of days and can trigger a number of additional inspection protocols. The inspections use independently validated, consistent methodology and involve questions to residents, families and staff to help to identify areas of concern. All 633 LTC homes in the province will receive a new inspection by the end of 2014, and annually thereafter.
