On November 27<sup>th</sup>, I visited Elim Village in Surrey to job shadow a care aide for a day. A big thanks to Board Director Ron Pike and his team for organizing this opportunity and allowing me to experience what it is like to work on the front-line.

#### New Additions to the Team

On November  $4^{\mbox{\tiny th}}$  the BCCPA welcomed new additions to our team.

**Keivan Hirji** has been hired to work on a six-month contract to work as Communications and Events Coordinator. He will be working on both BCCPA and SafeCare BC projects. In particular, he is helping to develop the SafeCare BC website and will be coordinating our new BCCPA Awards Ceremony being held in Victoria on February 19<sup>th</sup>.

**Michael Izen and Rebecca Livernois** will be working on contract to carry out the Core Review project. They will identify and catalogue some of the red tape our front-line employees and management face every day. In particular, how all that red tape can negatively impact those in care. The Core Review Report will be released to the public in early 2014.

### Removing Red Tape: Core Review

Earlier this year the BC Government announced it was going to undertake another Core Review process headed by the Hon. Bill Bennett. The first Core Review was conducted after Gordon Campbell became Premier in 2001.

In conjunction with the government's review, the BCCPA has decided it will also undertake to produce a report cataloguing the red tape facing everyone working in the continuing care sector. The report will focus on updating the "Dis-Org" chart that was released a couple of years ago. The chart helped to visualize the labyrinth of agencies, ministries and orders of government that care providers have to deal with and/or report to on a regular basis.

Our contractors **Michael Izen** and **Rebecca Livernois** will be working on this project over several months and are now in the field gathering information. I would encourage everyone to work closely with them to ensure the report is all encompassing. ### **BCCPA** Partners with OLTCA

I am pleased to report the BCCPA reached out to the OLTCA to partner on a special joint project and they have agreed.

In January, we plan to hire and supervise a recreational therapy co-op student and/or intern to identify "best practices" (examples) of successful recreational therapy programs and activities in residential care homes across Canada – with a focus in Ontario/BC regions.

The student will directly consult with care homes and write up to ten special profiles. In addition, they will catalogue 50-60 programs currently in use throughout Canada.

The "best practices" guide will also provide analysis regarding each program by:

- Complexity of implementation
- Cost (capital + operations)
- Multi-cultural adaptation
- Level of acuity
- Suitability for residents living with dementia
- Gender focus i.e. program geared toward women, men or both
- Physical capacity i.e. wheelchair-friendly

The BCCPA and OLTCA are planning on making the new online guide available to our members in the spring 2014. ### SafeCare BC: Update New Progress

There is a lot to report regarding progress being made with SafeCare BC.

On October 1<sup>st</sup>, the BCCPA signed a formal agreement with WorkSafeBC to help establish SafeCare BC. To immediately get things going, we established a new phone number, splash page and email contact to help ensure a continued two-way dialogue.

The Howe Group was also retained to help provide support services in the initial phase of organizational development. Some of their responsibilities include managing the hiring process of a new Executive Director, conducting a thorough training needs assessment and best practices review.

The BCCPA Board established a new SafeCare BC Hiring Committee. It is chaired by Liz Dutton, who works for Good Samaritan Society and is also on the BCCPA and DHA Boards. The committee drafted a job description in October and posted it on a variety of recruitment sites. There was significant response to the posting which closed on November 8<sup>th</sup>.

The committee then short-listed a number of candidates and will begin in-person interviews in December. It is anticipated the hiring process will be completed before the end of 2013 and a new ED will be in place sometime before the end of February 2014.

A new SafeCare BC Implementation Working Group was also established to provide an opportunity for additional engagement and consultation. Board Director Sue Emmons (Northcrest) serves as the Chair and is joined by Mary McDougall (Buron), Jeannette Thompson (representing DHA) and Stephen Symon (WorkSafeBC).

The Working Group will assist BCCPA staff and Board as we begin to transform SafeCare BC from concept into reality. They will also assist in the planning and establishment of the new society responsible for overseeing the affairs of SafeCare BC in the coming years.

Awarded to a member care provider or one of their employees who can demonstrate an innovation they have developed or introduced within the sector to improve the quality of care delivered.



### F.L.U.E. Campaign Underway

**Vancouver, B.C. (Oct 15, 2013):** With the flu season now upon us, the BC Care Providers Association (BCCPA) is launching a new F.L.U.E awareness campaign aimed at reminding people that hand washing before visiting friends and relatives in residential seniors care homes is the first line of defense against spreading the flu.

The F.L.U.E campaign, which stands for Friends/Family Lather Upon Entry, will be promoted through BCCPA members across the province. Care providers will be encouraged to post these electrostat posters on all public entry/exit doors between now and the end of flu season.

BCCPA CEO Daniel Fontaine says people visiting a care home often believe they are the ones at risk of picking up a flu bug or other virus. But visitors are more likely to be carrying a flu bug into a care home, oftentimes unknowingly. "We can't stress enough how important hand washing is," Fontaine said. "A good lathering up with soap and water, or with an alcohol-based hand sanitizer, is the best defense against spreading the flu or other microorganisms to vulnerable care home residents."

All of B.C.'s seniors care facilities have protocols and training in place to prevent the spread of illnesses. These protocols can include recommendations such as thoroughly washing:

- Before and after direct patient contact
- After completing tasks at one patient station before moving to another station
- Before procedures, such as administering intravenous medications
- Before and after contact with vascular access
- Before and after dressing changes
- After contact with items/surfaces at patient stations

The BC Centre for Disease Control (BCCDC) recommends the following hand washing steps to thoroughly rid your hands of potentially harmful germs.

- Wet your hands with warm water.
- Apply plain soap to your hands and rub together for 20 seconds (the length of time it takes to sing Twinkle Twinkle Little Star or Happy Birthday)
- Wash the front and back of your hands, as well as between your fingers and under your nails.
- Rinse your hands well for 10 seconds under warm running water, using a rubbing motion.
- Wipe and dry your hands gently with a paper towel or a clean towel. Drying them vigorously can damage the skin.
- Turn off the tap using the paper towel so that you do not re-contaminate your hands. When using a public bathroom, use the same paper towel to open the door when you leave.

#### Policy and Research Scan



#### British Columbia

- The BC government is conducting a national <u>executive</u> <u>search</u> for BC's new Seniors Advocate.
- Effective December 1, 2013, the BC *Hospital Act Regulation* is amended to add a duty to report adverse events, where adverse events include serious injury or death to a patient.
- Alternative models of seniors care. The <u>Car-ing Co-operatively Project</u> aims to develop a series of co-ops that will empower seniors in the provision of services they need. The project will develop elder care co-ops in three forms: seniors' co-op housing projects; aging in place support and foster care service co-ops; and co-op care homes. Seed development funding of up to \$20,000 is available for projects in BC, Alberta, Saskatchewan, New Brunswick and Newfoundland (BC Co-operative Association).

#### <u>Alberta</u>

• The <u>Alberta Seniors Advocate</u> will begin work on April 1, 2014, under the new *Alberta Health Act*.

#### <u>Ontario</u>

• Ontario coroner's office is cutting back on <u>nursing</u> <u>home death investigations</u>. Previously, the coroner automatically investigated every tenth death in each long term care home.

#### International

- New bill improves on nursing home surveys and surveyor training. A new House bill aims to improve the nursing home survey process, enhance whistleblower protections for surveyors and establish an advisory committee for CMS that would include skilled nursing facility administrators, directors of nursing and other stakeholders (McKnight's Long Term Care News).
- American College of Obstetricians and Gynecologists <u>committee opinion</u> recommends screening for elder abuse of patients older than 60 years to help identify victims of abuse and provide them with appropriate medical and psychosocial care and referrals. Older women are more vulnerable, less inclined to discuss abuse without direct questioning, more likely to accept or minimize the degree of their situations, and to remain silent as abuse continues (University of California, Center of Excellence on Elder Abuse and Neglect).

- Foster Care for Elderly: Like a New Home (New York Times, March 1994)
- Marmet Health Care Center, Inc. v. Brown, 132 S.Ct. 1201 (2012). This case involved three negligence lawsuits against nursing homes in West Virginia. In each case, a family member of a resident signed an admission agreement with the nursing home. The agreements included a clause requiring the parties to arbitrate all disputes (with some exceptions). When the residents died, the family members filed a lawsuit alleging negligence by the nursing homes. The trial court dismissed the suits, based on the agreement to arbitrate. The state court, however, ruled that an arbitration clause in a nursing home admission agreement is unenforceable in negligence disputes. The case went to the US Supreme Court, which ruled in favour of the nursing homes - it found that the West Virginia statute that barred mandatory arbitration provisions in nursing home contracts violated the Federal Arbitration Act, and that states could not limit the application of federal law to specific industries (nursing homes) or specific disputes (negligence).
