

## Balancing Rights, Care, Ethics, and Legal Context

With the <u>Cannabis Act</u> coming into force, there is much to learn about the regulation of cannabis by federal, provincial, and municipal governments.

Residential Care operators will have to balance rights in safely providing access to medical and recreational marijuana while respecting rights, safety, health and comfort of other residents, staff and volunteers.

## **Ethical For Residents**



Cannabis in residential care is ethically justifiable if it:

- provides improved Quality of Life
- provides improved Quality of Care (e.g. multiple sclerosis, chronic pain, reducing side effects of chemotherapy)
- is an informed decision with discussion of treatment options and explanation of associated risks (e.g. drowsiness/dizziness can increase risk of falls)
- there are strong protocols in place to govern use

## **Ethical for Professional Staff**



Cannabis in residential care is ethically justifiable for professional staff if they:

- Are appropriately trained and supported through educational programs
- Receive clear guidelines from their respective professional associations
- Have updated insurance
- Are protected from malpractice or allegations of unprofessional conduct

#### Park Place Policies

The Park Place Clinical Leadership Team has developed 2 major policies to address the legalization of cannabis:

- 1. Medical Marijuana use in Residential Care Homes
- 2. Drug, Alcohol and Substance Misuse

## Medical Marijuana Use in Residential Care Homes Policy

#### Some notable provisions are:

- The buying, selling, bartering or growing of medical marijuana is not permitted on Park Place property
- Residents are not permitted to share or borrow medical marijuana

- The order of Medical Marijuana will be added to the Medication Administration Record (MAR) and resident medication profile and will note "personal use"
- The Park Place Care Home will provide a secure storage location (e.g. locked cupboard/drawer) which will remain the property of the resident

- No solicitation role: When a supplier is invited to a Park Place
   Care Home to visit a resident, that supplier must limit their
   interactions related to medical marijuana to that specific client
   resident
- Park Place Seniors Living and staff will not aid in procuring medical cannabis for a resident

## Drug, Alcohol and Substance Misuse Policy

#### Some notable provisions are:

- Staff who are 'on call' must ensure they are not under the influence of drugs or alcohol during the 'on call' period as they may be required to make decisions/drive/attend work
- All staff must advise their manager if they are charged and/or convicted of a driving offence while under the influence
