#### 1. Annual membership dues:

- a. within 30 days of renewal date.
- b. any dues past 60 days will deem the membership as cancelled.
- c. all members have the option to pay quarterly.
- 2. Homes will be billed on beds/suites (Long-Term Care, Assisted Living and Independent Living.) Home health operators will be billed on hours of care.
- 3. In the case of Independent Living, if the member is being billed as a Service Provider, they will not be additionally charged for Home Health hours provided on their property.
- 4. A member who withdraws will not receive a refund.
- 5. A business which is sold in mid-year will not receive a refund, but the membership may be transferred to the new owner.
- 6. Annual dues will be established at the Annual General Meeting for the subsequent fiscal year.

Owners operating multiple sites have the option to:

- a) Pay the dues for each individual home, OR
- b) Pay the dues for all homes based on the total number of beds/suites with applicable corporate discount. If an organization does choose this option, invoicing showing the corporate discount will be placed on one invoice and directed to one contact person to facilitate a payment for the invoice.
- c) Home health franchises are exempt from this policy and will be treated as separate entities. Several franchised locations may apply for a group rate, which will be assessed on a case-by-case basis by BCCPA's Membership Services & Engagement Committee.

Independent Living \$10.00/suite/year until April 1, 2021, then

\$20.00/suite/year\*

Minimum Rate: \$400.00/year

Home Health \$0.02/hour/year

Minimum Rate: \$400.00/year Maximum Rate: \$6,000.00/year

Commercial

Category 1: four FTEs or less \$550/year Category 2: Over four FTEs \$1,100/year

Associate Dues \$595/year
