EquipCare BC

Program Guidelines & Eligibility

PROGRAM OVERVIEW

The provincial government has renewed an additional two years of grant funding to the BC Care Providers Association in the amount of \$14 million for EquipCare BC to promote safety and quality of life improvements for seniors and those who care for them in publicly funded long-term care and assisted living homes.

WHO CAN APPLY FOR FUNDING?

To be eligible for program funding, all the following criteria must be met:

- Home operates in the province of BC.
- Includes non-health authority owned and operated homes.
- Includes publicly funded long-term care homes.
- Includes publicly funded assisted living operators as listed on the <u>Seniors'</u>
 Assisted Living Registry under the "Seniors" residence type *SN*.

Further Note: Currently, health authority owned and operated homes, private pay, independent living residences, and home health operators are not eligible for program funding.

Note: The "up to" eligible amount only applies to public funded units or beds.

*The "up to" eligible amount may vary for Period 2 dependent on the number of applications and funds remaining from Period 1.

Note: If the Period 1 application is missed, amounts do not carry forward to Period 2.

WHAT IS THE APPLICATION PROCESS?

Begins: When the *Terms & Conditions* are accepted, and the application is received prior to the closing date of the application period.

Ends: When the applicant receives a decision on grant funding.

Note: Period 2 applications are considered for adjudication only if there are no outstanding documents, and the grant payment was issued for Period 1. Priority is given to homes that did not apply in Period 1.

WHAT IS THE FUNDING PROCESS?

Begins: When the grant recipient receives the funding approval to proceed with purchases and implementation.

Ends: When the grant recipient receives the funding and completes a satisfaction survey.



Note: For grant funding eligibility, invoices and proof of payment documents cannot pre-date April 4th, 2023, for Period 1 and April 1st, 2024, for Period 2.
