The long-term care injury rate is almost EIGHT times the provincial average across ALL occupations.


THE INCONVENIENT TRUTH UNDERSTANDING THE REAL COST OF WORKPLACE INJURY

16,307 TOTAL WORKDAYS LOST IN HOME AND COMMUNITY TO INJURIES. EQUIVALENT TO LOSING 65 FULL-TIME STAFF






