## SENIOR ON SENIOR ABUSE: WHAT DO YOU DO WHEN YOUR LOVED ONE IS THE AGGRESSOR

New Care to Chat Speaker Series Tackles Challenging Issues

**Vancouver, B.C. (Sept. 11, 2013)** — The field of seniors care is diverse, with many sectors playing an important role. To foster knowledge exchange among the continuing care sector and others that deliver services to seniors, the BC Care Providers Association (BCCPA) is hosting a four-part speaker series that will address challenging issues facing key decision makers, business leaders, care providers, as well as other professionals, seniors and their families.
